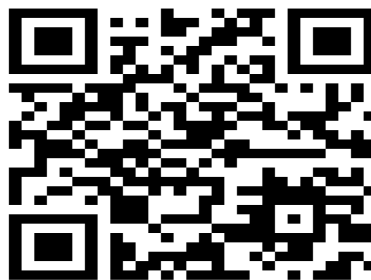

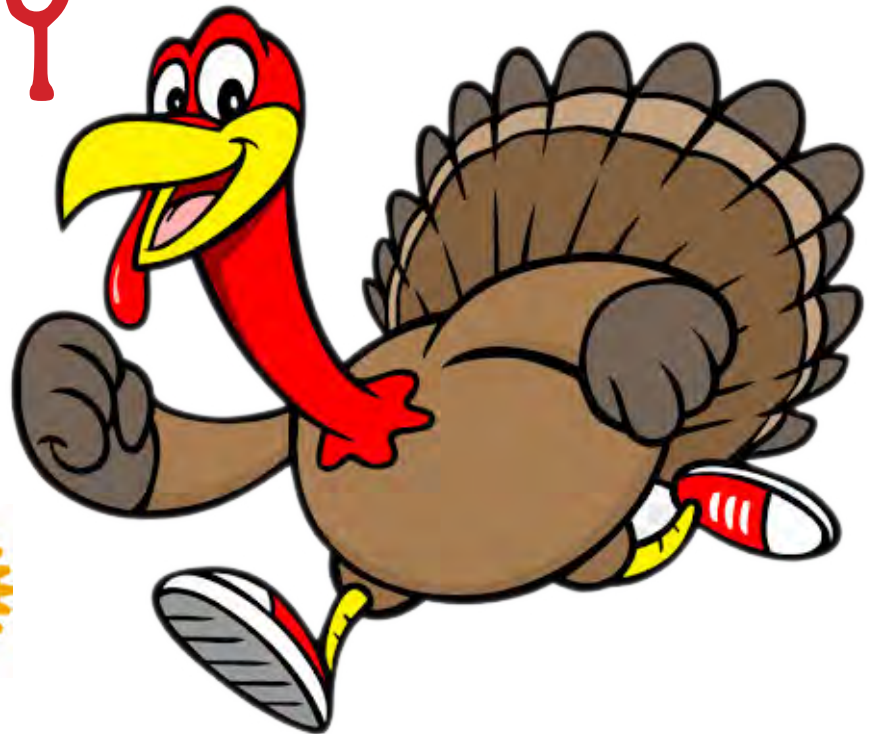

For Interested Clubs

What is IMPACT?

IMPACT is **an innovative satellite club** model we call a **companion club**. We at IMPACT prefer to call them companion clubs as these satellite clubs remain attached to the sponsoring club regardless of size.

IMPACT companion clubs meet only for service projects. Members **get in, serve, and go home.** The bread and butter of these companion clubs is the **microproject**, smaller projects which require little coordination but accumulate to have a massive impact on the larger community.

Why IMPACT?

Service unites us. Membership in Rotary International in the United States is in decline. The traditional club model requires attendance at meetings that may not fit the schedule of many people who are otherwise Rotarians **without the pin.**

Attaching an IMPACT companion club allows legacy clubs to offer a wider menu of membership options to prospective Rotarians. Some members will join the IMPACT model, which fits their lifestyle and interests. Others will be attracted to the meet-and-eat model of a traditional Rotary club.

IMPACT companion clubs address the issue of Rotary being an aging club. Legacy clubs are full of older, very generous Rotarians, many of whom cannot perform a lot of physical service. Adding an IMPACT companion club attracts a younger demographic, which can perform the functions of the currently lacking **worker bee.**

What are the benefits of IMPACT?

IMPACT companion clubs and their legacy clubs utilize the IMPACT website, which provides members a quick and easy way to **track service hours, convert donations to service hours, submit service photos, and access a service calendar.**

IMPACT also encourages additional programs such as **Service Together**, in which all Rotary clubs within a county perform service together despite being in different clubs, and **PH36**, an initiative that fosters leadership in younger Rotarians.

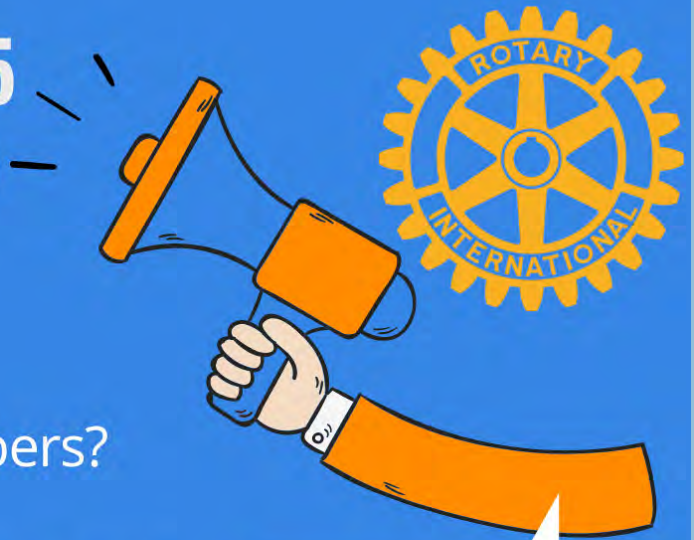

Article 16 Governors

16.010. Qualifications of a Governor-nominee.

16.020. Qualifications of a Governor.

16.030. Duties of a Governor.

16.010. *Qualifications of a Governor-nominee.*

Unless excused by the board, the person selected as a governor-nominee shall at the time of selection:

- (a) be a member in good standing of a functioning club in the district;
- (b) have served as club president for a full term or as charter president for at least six months;
- (c) demonstrate willingness, commitment, and ability to fulfill the duties and responsibilities of a gin section 16.030.;
- (d) demonstrate knowledge of the qualifications, duties, and responsibilities of governor as prescribed in the bylaws; and
- (e) submit to RI a statement that the Rotarian understands those qualifications, duties, and responsibilities is qualified for the office of governor, and is willing and able to assume and faithfully perform thousand responsibilities.

16.020. *Qualifications of a Governor.*

Unless excused by the board, a governor, when taking office, must have attended the international assembly for its full duration, have been a Rotarian for at least seven years, and continue to possess the qualifications in section 16.010,

16.030. *Duties of a Governor.*

The governor is the officer of RI in the district, functioning under the general control and supervision of the board. The governor shall inspire and motivate the clubs in the district. The governor shall ensure continuity within the district by working with past, current, and incoming district leaders. The governor is responsible for:

- (a) organizing new clubs;
- (b) strengthening existing clubs;
- (c) promoting membership growth;
- (d) working with district and club leaders to encourage participation in a district leadership plan as developed by the board;
- (e) furthering the Object of Rotary by providing leadership and supervision of the clubs in the district;
- (f) supporting TRF;
- (g) promoting cordial relations among the clubs and Rotaract clubs and between the clubs, Rotary and RI;
- (h) planning for and presiding at the district conference and assisting the governor-elect in planning and preparing the PETS and the district training assembly;
- (i) conducting an official visit to each club, individually or in multi-club meetings, that maximizes the governor's presence to:
 - 1. focus attention on important Rotary issues;
 - 2. provide special attention to weak and struggling clubs;
 - 3. motivate Rotarians to participate in service activities;
 - 4. ensure that the club constitution and bylaws comply with the constitutional documents, especially following councils on legislation; and
 - 5. personally recognize the outstanding contributions of Rotarians in the district;
- (j) issuing a monthly communication to each club;
- (k) reporting promptly to RI as required by the president or the board;
- (l) providing the governor-elect, before the international assembly, full information about the condition of clubs and recommended action to strengthen them;
- (m) assuring that district nominations and elections comply with the constitutional documents and RI established policies;
- (n) inquiring regularly about the activities of Rotarian organizations in the district;
- (o) transferring district files to the governor-elect; and
- (p) performing any other duties as are inherent of an RI officer.

The Bob Williams Memorial Rotary Scholarship Program

BOB WILLIAMS; ROTARIAN OF OMNIPRESENT GOOD WORKS



If you walked anywhere with Bob Williams in downtown Pittsburgh, you alternated between half running to keep up with him and stopping on a dime to talk with the numerous friends that Bob would inevitably meet. Always gracious and mindful, Bob would never fail to introduce you to his (now your) friend.

The Old Testament 2 Chronicles 16:9 states "For the eyes of the Lord move to and fro throughout the earth that He may strongly support those whose heart is completely His." This passage describes Bob's life as a recipient and conduit of blessings both material and divine. Bob was only 65 when he left us on December 15, 2009.

Those walks were microcosms of Bob's life: he was a dynamo that seemed never to pause to rest, yet always paused to do random acts of thoughtfulness. His span of good works ran the gamut from contributing to The Rotary Foundation, to shaking hands with the speaker at the end of the weekly meeting (his hand inconspicuously held a personal check for the speaker's charitable organization), to giving money to the beggar woman who sat outside the Forbes Avenue CVS.

Bob was born in Robinson Township. His father, David E. Williams, was a legendary educator and administrator in the Montour School District; a junior high school building in that District bears his name. Bob attended Swarthmore College and Georgetown University Law Center. He was married for 41 years to his wife, Teresa. They have three children: Ben, Lizabeth, and Matthew, and seven grandchildren.

Bob's tenure as a Rotarian lasted for over 30 years. He was a Paul Harris Fellow eight times over – an inspiration to all Rotarians. Bob wore many hats – literally and figuratively. At Rotary and beyond, he was famous for his hat collection, which ranged from the ridiculous (a stuffed moose), to the sublime (a native American headdress).

Bob was a Rotarian's Rotarian. He worked tirelessly for all his friends, especially in support for The Rotary Foundation and its endowment. Bob gave his talents and time freely to anyone who made a bequest to The Rotary Foundation's Permanent Fund.

Bob was also blessed with a fulfilling career on which to exercise his profound intellectual curiosity. He was an associate, then a partner, with Eckert Seamans, one of Pittsburgh's premier law firms. In 1995, he resigned from that firm on an amicable basis to lead his own team of lawyers. On Halloween of 1995, the firm of Williams Coulson was born. Throughout his career, Bob was listed consistently in many Super Lawyer and Best Lawyer publications, including a listing in the Best Lawyers in America.

Many of us who had the privilege to serve on a committee with Bob were blessed to interact with one of finest men God created. He was special. His entire adult life, Bob quietly, in his unassuming manner, gave hundreds of youth educational opportunities to grow up to become gentle and productive adults - the fabric that was Bob's character. He gave witness to the highest degree of professionalism, gentleness, fairness, compassion and made giving an art. Simply, many of us were privileged to know and call him friend. He made all those he met and touched better human beings. A friend said of Bob: **"One of the BEST of God's children, as to how he lived his life and treated others."** Another stated, **"Our loss was heaven's gain."**

Bob was trusted by his peers. He earned the loyalty and devotion of his clients, many of whom enjoyed decades-long relationships of representation and friendship. As one who lived the Gospel message, Bob took the same care with those of modest means that he took with the captains of industry.

Bob's endowed gift will forever provide scholarships to deserving youth and fund many local and international Rotary Foundation scholarships, ensuring that his legacy of gentleness, fairness, compassion and the privileged art of giving will continually be bridged to future generations.

At the Rotary Club of Pittsburgh's 23 Dec 09 meeting, the day after Bob's passing, Jim Droney, past president of Pittsburgh Rotary, described Bob perfectly: **"Bob always operated in that gentlemanly, modest, understated style that has all too often vanished from the business world today, . . . He was substance, not style"**. Present at that meeting was Bob's son, Ben, who had just been inducted into the Rotary Club of Scranton, PA earlier that week and was a visiting Rotarian that day at the Pittsburgh Club.

Thank you friend Bob.

The Bob Williams Memorial Rotary Scholarship Program



THIS IS A NEED-BASED SCHOLARSHIP (School Year 2022-23)

The Bob Williams Memorial Rotary Scholarship Program exists for high school seniors or non-traditional students. This program will award scholarships (up to \$5,000 for an academic year) to those candidates chosen by the Williams Scholarship Committee. The Scholarship will be paid to the educational institution. Below you will find a list of requirements and rules. Failure to adhere to our rules or furnish the

required application components will render the submitted application disqualified.

Criteria for Eligibility:

(This is a need based scholarship)

- Applicant must be a citizen of The United States
- Applicant must have a 2.5 GPA or higher in their current year of study, regardless of the field of study
- Applicant must be a high school senior who is applying to a state-certified, post-secondary institution
- Applicant must be currently attending a high school within the boundaries of Allegheny & Beaver Counties. Burrell, Kiski & New Kensington-Arnold school districts in Westmoreland county
- All private, charter and parochial senior students within the designated service areas are eligible

In the case of non- traditional students (who are not a graduating senior from a High School), the applicant must:

- Be a citizen of The United States
